

# RATES FOR LIVE CONCERTS AND MUSIC-CENTRIC EVENTS

## Basis for Assessment:

### 1. 2% of Net Ticket Sales (subject to minimum fee which is determined based on seating capacity)

Ticket Sales = Gross Ticket Sales

Less: Actual Amusement Tax (max 30% of GTS)

Actual Commission of Ticket Outlets (max 10% of GTS)

### 2. Complimentary Tickets with no Printed Value

A. No charge if number of complimentary tickets is not more than 10% of the total number of tickets sold.

B. If quantity is more than 10% of tickets sold, the excess will be assessed based on 1% of the total value of the said complimentary tickets.

C. Each complimentary ticket shall be valued based on the equivalent price of a ticket in the same section/category (e.g., VIP, Lower Box, etc.).

### A. TICKETED (WITH ADMISSION FEE)

#### 1. Gross Ticket Sales Per Show (subject to minimum fee determined based on seating capacity)

#### 2. Complimentary Tickets with no Printed Value

- A. No charge if number of complimentary tickets is not more than 5% of the total number of tickets sold.  
 B. If quantity is more than 5% of tickets sold, the excess will be assessed based on 2% of the equivalent price of a ticket in the same section/category.

### B. NON-TICKETED (WITHOUT ADMISSION FEE)

2% of Total Production Cost (subject to minimum fee determined based on seating capacity)

#### NOTE:

If additional music are played (before, during breaks, and/or after the show), that are not part of the dramatic performance, a **PHP 5,000.00 blanket fee** shall be payable on a per show basis.
